**No stand may be completely or partially cleared before the end of the exhibition. In case of violation, the charged deposit in the amount of 300 euros will be retained.**

### 3. Stands

The stands will be delivered ready for occupancy by the organizer. The dividers are approx. 2.25 m high and may be nailed. Use sturdy stand shelves and **not shelves resting on angle brackets** that must be bolted to the dividing walls. Metal brackets for gun racks or hanging shelves, etc. may be hung and screwed over the top of the walls. All nails and screws must be removed at the end of the event. The stands are closed off at the front by a head panel approx. 20 cm wide, which ends with the top edge of the frame. This may be nailed.

### 4. Exemption permit

Every supplier of unrestricted weapons and edged weapons must submit an application for an exemption permit in good time before the start of the fair (see attached application). **Firearms requiring a permit may not be offered.**

### 5. Compliance with §86a StGB

The exhibitor undertakes to strictly comply with §86a of the German Penal Code (StGB) as amended on May 31, 1978, according to which, among other things, it is prohibited to exhibit, exchange or trade in such items that display or bear the marks of former National Socialist organizations (masking). The more stringent provisions of the Weapons and War Weapons Control Act must be observed at all costs. Trade in counterfeits or imitations is prohibited. The exhibitor also undertakes to comply strictly with §40 WaffG.

In the event of violations of the provisions of §86a StGB and the provisions of the Weapons and War Weapons Control Act, the Exhibition Management has the right to immediately close and dismantle the exhibitor's stand. Any claims for damages are excluded.
